## PREPARATION AND SEPARATION OF RESOURCES FOR RECYCLING CENTERS

- 1. Aluminum-made Cans and Tabs** empty, flatten, sort with no other aluminum.  
  
**Aluminum-made Foil Wrap, Food Trays and Pie Pans and Siding** clean well, flatten, sort with no aluminum-made cans or tabs.
- 2. Cans (bi-metal, tin, steel and coated)** clean well, remove labels, flatten.
- 3. Cardboard (brown corrugated inside when torn)** clean well, dry, flatten and box, bag or bundle. Brown paper bags may be sorted with cardboard.

**Reminder** plastic, tin, wax coated cardboard, white board, gray board NOT accepted for transfer to any recycling center.

**4. Glass (amber, blue, clear, green)** clean well, remove caps, labels, rings and sort by color.

**Reminder** ceramic-based and clay-based items, drinking glasses, light bulbs, and window glass NOT accepted for transfer to any recycling center.

**5. Magazines, Newspaper, and Brochures** clean, dry, staples removed and bag, box or bundle.

**6. Oils** in closed containers accepted for transfer to recycling center.

**7. Plastic Bottles, Plastic Containers** No. 1 and No. 2 clean well, remove caps, labels, rings and flatten. **Reminder: motor oil containers and cooking oil plastic containers NOT accepted for transfer to any recycling center. **Open or closed burning of plastics, other petroleum-based materials and most other garbage, trash, waste materials - whether in cement enclosures, metal barrels or containers is illegal in Wisconsin under ss. NR 429.04 and NR 502.11 Wis. Adm. Code.****

### SOLID WASTE MATERIALS DISPOSAL INTO COMPACTOR

1. **Ashes** cold, enclosed in CLEAR bag and received during months of March through October.
2. **Garbage, Trash, Waste** enclosed in CLEAR bag.
3. **Fees Assessed by the Transfer Station Attendants** \$3.00 per CLEAR bag, \$6.00 per barrel, \$20.00 for a small pick-up truck load, and \$30.00 per large pick-up truck load. **Attendants assess add-on fee for all solid waste materials not in CLEAR bags.**

- 5. Heavy Items, Large Items** include: air conditioners, boilers, carpet, cement decorations and vases, chairs, clothes dryers, clothes washers, dehumidifiers, dishwashers, drywall, fiberglass and foam insulation, flooring, freezers, furniture, furnaces, humidifiers, fluorescent light bulbs, mattresses, mercury encased items, ovens, refrigerators, shingles, sofas, stoves, swimming pools, televisions, toilet bowls, vinyl siding, water heaters and water softeners. ### **MANAGEMENT OF VEGETATIVE MATERIALS FROM YARDS**

Have a plan for composting lawn clippings, branches, brush, garden debris, grass, leaves, roots, shrubs and vegetation that is woody; and root balls, stumps and tree trunks. Vegetative materials from residential yards, farm yards and business yards NOT accepted at the Transfer Station and banned in all Town of Maple Grove Right-A-Ways.

## **MANAGEMENT USING FOR-HIRE-HAULERS AND SERVICES**

Deciding for what to do with used ag plastic film, fiberglass and foam building materials, non-recyclable items, plastics components and plastic containers used in businesses, farms, households and on property can be difficult. Town of Maple Grove business owners, farmers, and residents property owners have responsibility for personal direction using for-hire-haulers and services of their choice for scheduling materials management.

Also, all materials placed into a for-hire-hauler's transfer bins or transfer dumpsters belong to that business waiting for scheduled pickup. ### LAND CONTRACTORS, RENTERS, TENANTS

Best practice includes property owners informing their land contractors, renters and tenants with oral and written information. **Personal dumping in TOWN OF MAPLE GROVE RIGHT-A-WAYS and at the site TOWN OF MAPLE GROVE TRANSFER STATION when not in operation is not nice as well as**

**illegal and require cleanup.** Per Town of Maple Grove Recycling Ordinance 1.22 persons who violate may be required to forfeit no less than \$25.00 or no more than \$500.00 for each subsequent violation.
